Course Prefix and Number: CHD 270

Credits: 3

Course Title: Administration of Childcare Programs

Course Description: Examines the skills needed for establishing and managing early childhood programs. Emphasizes professionalism and interpersonal skills, program planning, staff selection and development, creating policies, budgeting, and developing forms for recordkeeping. Lecture 3 hours per week.

General Course Purpose: Students will gain knowledge in the development of language and perceptual skills of young children. This course is a third semester requirement for the associate degree and a requirement for the Early Childhood Education - Advanced Career Studies Certificate.

- q. Demonstrate knowledge of staff scheduling in early childhood settings;
