All academic records provided must be legible and must be able to confirm whether or not you earned academic credit at each institution during the time you received financial aid. If you are unaware of where you received aid, you may log into Student Aid for assistance at www.studentaid.gov.
- B. If you did not earn any academic credit at one or more of the schools you received aid, provide an explanation for EACH of the schools where you did not earn any academic credit. Attach any supporting documentation (i.e., military obligations, police reports, medical documentation, etc.). The Office of Financial Aid will review your statement and supporting documentation to determine if you are eligible to continue receiving financial aid assistance. If your appeal is denied, you have the opportunity to contact the Office of Financial Aid and submit a subsequent appeal statement providing additional explanations. If your appeal is denied, you may also successfully complete six credit hours at the college in order to regain eligibility for financial aid. Please keep in mind that you would not be permitted to use financial aid to pay for these six credit hours.
